1.0 Details of Fees

- 1.1 School Fees Include: Daily Classes, Exam Fees, Inter-house Activities. Please note that Treks/Outdoor Education Programme, Annual Programme, Library, Swimming, Horse riding, Excursions, Computer, Additional Music Lessons, Exchange Programmes, additional Sport Coaching, Tutorial Classes etc shall be charged extra.
- 1.2 Residential Fees for Boarding (Food) Include: Ration, Kitchen Staff Salary, Cooking Fuel & Utilities for Kitchen.
- 1.3 Residential Fees for Boarding (Lodge) Include: Residential Staff Salary, Utilities & Services, House Keeping Expenses.
- 1.4 Residential Fees for Boarding (Miscellaneous) Include: Security Expenses, Laundry Services, Staff Salary for Preparatory Classes and Daily Sports.

2.0 Terms & Conditions for Fees Payments

- 2.1 Monthly School Fees & Residential Fees (as per A & B) shall be paid in advance within the 10th of every month, irrespective of whether the parent/guardian receives the bill or not in time. A Late Fee fine shall be levied on all outstanding Fees as mentioned under the rules for fees payments. Admission Fees (as per D) shall be paid at the time of Admission.
- 2.2 Fees may be increased by 10% every year to cover inflation as per the decision of the Management Board.
- 2.3 Fees to be reviewed and revised after every four years as per market conditions or earlier under circumstances beyond the control of the School.
- 2.4 Please note that there will be no re-admission fees charged every year, beyond the Maintenance Fees as per D.3
- 2.5 Imprest money shall take care of all consumable and expendable items, the expenses of which shall be deducted from the above sum. Items considered shall be as follows:
 - Book, stationery, clothing,
 - Excursions & educational visits,
 - Pocket Money,
 - Medical Expenses & Insurance,
 - Transportation for Home Weekend
 - Any other Incidentals

If the Imprest money is not enough to cover the costs, the parents/guardians may be required to deposit an additional sum for further expenses.

All Bill and Vouchers shall be kept and forwarded to parents/guardians periodically. For the convenience of Parents and proper maintenance of records, a City Office has been established at Heritage Plaza-II Kamaladi, for all correspondence and inquires.

3.0 Rules for Fees Payment

- 3.1 The last day for payment of the monthly Fees shall be within the 10th of every month.
- 3.2 A late Fee Fine of NRs.30.00 per day will be levied from the 1st of the 2nd month till the last of the same month.
- 3.3 A late Fee Fine of NRs.100.00 per day will be levied for the 1st of the 3rd month till the date of Fee Payment.
- 3.4 Until all outstanding Balance of Payment is made within the same Academic Year, the yearly report card will be withheld along with re-admission of the student in the next academic year.
- 3.5 The Imprest Money will take care of all consumable and expendable items except for long yearly excursions/tours to different districts of Nepal or outside the Country. Separate billings will be done for this activity.
- 3.6 If the total Monthly Fees for the 12 months duration of the whole academic year is paid in advance, in one installment, at the beginning of the year, then a 4% discount shall be given. If advance of Fees for only 6 months is given in one installment then a 1.5% discount will be given.
- 3.7 If two children of the same parents are admitted to the School the Refundable Security Deposit of one of the child is waived.
- 3.8 If a Student is to be withdrawn within an academic year, a three months written notice should be given. If three months written notice is not given then three months fees will be charged in lieu of notice.
